A documents leak from an anonymous insider—later identified as a former lead instructional designer at Paul Mitchell Schools—exposed internal workbooks, training modules, and pedagogical frameworks labeled “Cutting Workbook Answers.” These were not mere teaching guides; they were the codified DNA of a pedagogical philosophy, refined over two decades, now under scrutiny. The revelation ignited a storm of debate: Was this a whistleblower act, a corporate recalibration, or a symptom of a deeper crisis in creative education? In a 2024 SEC filing, the company disclosed a strategic pivot: integrating AI-assisted feedback loops and modular, project-based learning into
