Intellectuals like Remarque viewed this not as a failure of institutions alone, but as a symptom of deeper cultural atrophy—an erosion of empathy, critical thought, and collective responsibility. Arendt, observing from the margins, later diagnosed this as the birth of totalitarianism: a system that replaces pluralism with ideological absolutism, history with myth, and human dignity with instrumental rationality. Bloch's **Materialismus der Utopie** (1930) articulated this transformation with penetrating clarity: ideology, he argued, ceased to be abstract doctrine and became a lived force, shaping behavior, memory, and social relations. Bloch, more academically embedded, taught philosophy at Heidelberg but wrote with public urgency. His **Principles of Philosophy** (1932) fused Hegelian dialectics with Marxist materialism, arguing that material conditions shape consciousness, but consciousness could transcend them through revolutionary praxis. His lectures drew students and workers alike, forming a bridge between academic theory and grassroots struggle.
