Expert Dr. Naomi Chen, a computational physicist at Caltech, articulates this synthesis: “C does not replace the mathematics—it exposes its practical consequences. When a student sees their code produce a delta-function-like node distribution in a 1D well solver, they grasp that quantization isn’t just a mathematical postulate—it’s a measurable physical constraint enforced by discretization.” This embodied rigor bridges the gap between symbolic
