The 1903 creation of the Bureau of Corporations—the first federal agency dedicated to antitrust oversight—signaled a new era of economic surveillance. The Interstate Commerce Commission, strengthened under Filson Young's leadership, began to enforce rate transparency across rail networks. The Department of Agriculture, expanded under Secretary William Jennings Bryan, launched scientific farming extension programs that democratized agrarian knowledge. But the real engine of transformation lay in regulatory innovation. The Pure Food and Drug Act (1906) and Meat Inspection Act, catalyzed by Upton Sinclair's *The Jungle*, were not merely consumer safeguards—they were institutional breakthroughs. For the first time, the federal government assumed responsibility for public health, bypassing state-level inadequacies and setting national standards. The Federal Reserve System, established in 1913 after years of congressional wrangling, emerged from the panic of 1907 and the recognition that fragmented banking regulation threatened national stability. Each agency—FDA, Fed, ICC—was a prototype of technocratic governance, blending expertise with accountability, even as it faced fierce opposition from incumbents. The era's geopolitical context further shaped its trajectory. The Spanish-American War (1898) had thrust the U.S. into imperialist entanglements, exposing contradictions between democratic ideals and colonial practice. The Federal Reserve Act (1913), born from decades of banking panics, created a central bank with decentralized power, capable of managing liquidity and credit—a stark departure from the chaotic gold-standard regime. But these reforms were not spontaneous. They were catalyzed by a media ecosystem: muckrakers like Lincoln Steffens, whose *The Shame of the Cities* (1904) exposed municipal corruption, and Ida Tarbell, whose *History of the Standard Oil Company* (1904) dismantled the myth of corporate benevolence. Their work, amplified by Progressive newspapers and lectures, shifted public discourse from individual morality to systemic failure. Industry, Labor, and the Struggle for Power

The relationship between capital and labor was the era's battleground. Trusts like U.S. Steel (founded 1901 by J.P. Morgan), Standard Oil, and the Carnegie Steel Company wielded unprecedented control. They manipulated prices, suppressed unions, and shaped politics through lobbying and patronage. The 1902 Coal Strike, where 140,000 miners faced starvation while owners hoarded profits, became a turning point. Roosevelt's intervention—threatening federal seizure—was not altruism; it was a demonstration that the state, not capital, would regulate industry. The resulting "Roosevelt Accords" granted arbitration rights and public scrutiny, marking the first federal endorsement of labor's right to organize. But progress was fragile. The 1914 Ludlow Massacre, where National Guard troops killed striking coal miners in Colorado, revealed the violence underlying industrial peace. The AFL's craft unionism excluded unskilled workers, while the IWW's radicalism was crushed by federal repression. The era's labor reforms were thus partial, constrained by racial exclusion—Black workers were barred from many unions—and gender bias, with women often confined to lower-paying, less organized sectors. Industry, however, adapted. Vertical integration, pioneered by Rockefeller and Carnegie, allowed dominance through control of supply chains. The rise of scientific management—Taylorism—sought to optimize labor, reducing wages and increasing surveillance. Yet even here, resistance emerged: Ford's \$5 day (1914), though paternalistic
