The geopolitical and economic context of the American South in the late 19th century was critical. After Reconstruction, Southern elites sought to reestablish control through Jim Crow laws, disenfranchisement, and racial violence. The cross, once a symbol of spiritual authority, was repurposed as a civic icon—struck into the fabric of public life, displayed on courthouses, schools, and government buildings. Simultaneously, lynching became a tool of economic and social discipline, reinforcing a racial caste system that preserved white labor dominance and suppressed Black mobility. The tension persists: can a symbol co-opted by oppression ever be fully redeemed? The lynching tree, by contrast, has long been a suppressed memory. Unlike the cross, which was absorbed into national mythos, the lynching tree remained buried in local archives, oral histories, and collective silence. Historian David W. Blight’s work on memory and racial violence highlights how America’s racial history has been selectively remembered—celebrating martyrs of the Confederacy while burying the corpses of lynching. The absence of a national memorial to lynching until the National Memorial for Peace and Justice (2018) in Montgomery reflects a deeper cultural refusal. Economically, lynching was not merely punitive; it was preventive. By terrorizing Black communities, it preserved a low-wage labor system and suppressed political organizing. The wood of the lynching tree thus became a repository of unacknowledged

loss—its knots and scars encoding stories of family rupture, community trauma, and systemic erasure. Internationally, parallels emerge. A 2021 survey by the Equal Justice Initiative found that fewer than 30 U.S. cities had formal memorials to lynching sites, though that
