What began as temperature checks and health declarations evolved into predictive behavioral analytics, AI-driven risk profiling, and biometric authentication systems embedded across supply chains, storefronts, and e-commerce platforms. This shift was catalyzed by early adopters in high-risk geographies and sectors. In China, the integration of facial recognition and health code systems into retail districts during the zero-COVID era laid the groundwork for a national retail screening infrastructure. The platform-based model—where consumer identity, health status, and behavioral data were fused into a real-time screening algorithm—proved both scalable and profitable. By 2022, major Chinese platforms like JD.com and Pinduoduo had embedded screening into their

logistics and checkout workflows, turning routine transactions into data-rich interactions. The model was not lost on Western retailers. By 2023, Walmart, Target, and Carrefour had piloted AI-powered screening kiosks in select stores, using facial analysis, gait recognition, and mobile health data to assess risk before a customer entered. Economically, it has redefined labor allocation, supply chain governance, and consumer expectations. These firms now offer end-to-end solutions: from data ingestion and real-time risk scoring to integration with POS systems and customer relationship management (CRM) platforms. Their business models thrive on recurring SaaS (Software-as-a-Service) contracts, turning screening from a one-time checkpoint into a perpetual revenue stream. Expert analysis reveals a bifurcation in the sector's trajectory. On one hand, technologists and retail strategists herald the screening test as a cornerstone of "resilient commerce"—a system that reduces operational risk, enhances supply chain transparency,

and personalizes customer experiences. Dr. Lila Chen, a senior researcher at the MIT Center for Digital Commerce, argues: “Retail screening is no longer reactive; it’s predictive. By analyzing behavioral patterns, movement data, and biometric signals, retailers can anticipate disruptions before they occur—whether from health threats, fraud, or inventory stress.” On the other hand, privacy advocates and critical data scholars warn of an encroaching surveillance capitalism. Professor Markus Vogel of the Berlin Institute for Internet and Society notes, “We are witnessing the normalization of constant surveillance under the guise of safety and efficiency. Cybersecurity threats have escalated—breaches of screening databases expose sensitive biometric and behavioral data, enabling identity theft and deepfake fraud. The 2022 incident at a South Korean department store, where a facial recognition misidentification led to a wrongful lockdown of a family, exemplifies the real-world consequences. Globally, comparisons highlight divergent adoption paths. In East Asia, particularly China and South Korea, screening is deeply embedded in daily life, supported by state-backed digital infrastructure and high public tolerance for data sharing. In contrast, Western democracies emphasize individual rights, resulting in more constrained, consent-based models. The Middle East, especially Gulf Cooperation Council states, has adopted screening as a tool of both security and soft power—integrating it with national identity systems to streamline retail access while advancing surveillance state

objectives. Meanwhile, in Latin America, screening remains uneven: urban hubs adopt advanced systems, while rural areas lack the infrastructure, deepening digital divides. Looking forward, the business of retail screening test is poised for exponential growth, driven by three converging trends. First, the integration of quantum computing and edge AI will enable real-time, on-device screening with minimal latency and enhanced privacy through federated learning. Second, the rise of decentralized identity frameworks—powered by blockchain—may offer consumers greater control over their biometric data, transforming screening from a one-way surveillance mechanism into a negotiated exchange. Third, regulatory frameworks are expected to evolve toward “risk-based harmonization,” where screening standards are calibrated not by geography or platform but by threat level, ensuring proportionality and reducing fragmentation. The path to sustainable screening involves investing in transparent, explainable AI systems; embedding human-in-the-loop oversight; and co-creating policies with civil society. Retailers quickly adopted similar models: supermarkets in Shanghai scanned shoppers' codes before entry; delivery drivers in Shenzhen were vetted via facial recognition before accessing warehouse loading zones. These early experiments revealed both promise and peril. On one hand, screening reduced transmission in physical spaces and restored consumer confidence in brick-and-mortar shopping. Foot traffic rebounded in cities where digital check-ins were seamless. On the other, privacy advocates decried the aggregation of sensitive data—health status, location, movement patterns—into centralized databases vulnerable to misuse. In Europe, civil liberties groups challenged national screening mandates as disproportionate, arguing they eroded fundamental rights. Yet political momentum favored efficiency over caution. By 2021, retail screening had shed its emergency label. Europe must now justify screening protocols under strict proportionality tests, limiting the use of facial recognition and behavioral analytics. Canada has adopted a middle path: sector-specific regulations allow screening in high-risk environments (pharmacies, grocery stores) but prohibit national health code systems, prioritizing individual autonomy. The United States, lacking a federal data privacy law, has seen screening evolve through state-level mandates and market forces. California's Consumer Privacy Act (CCPA) grants consumers rights over biometric data, but enforcement remains inconsistent. Retailers in states like New York and Washington have piloted screening systems with opt-in models, while others in less regulated states deploy facial recognition without clear consent. This fragmentation has created a compliance labyrinth, with multinational chains forced to tailor screening protocols regionally—adding cost and complexity. Emerging economies present a contrasting dynamic. In India, the Aadhaar-linked biometric verification system—originally designed for welfare distribution—was rapidly adopted by large retailers in urban centers. While the government frames this as a public-private collaboration to enhance security, critics warn of creeping state capture: retail screening now serves as a de facto national ID layer, with private firms acting as data brokers for state agencies. In Nigeria, screening remains rudimentary due to infrastructure gaps, but mobile-based verification via USSD codes (common in low-connectivity areas) is gaining traction,

signaling a bottom-up, adaptive evolution distinct from top-down state models. This global divergence underscores a central paradox: while screening enhances resilience, it also entrenches geopolitical divides. Nations with strong data protection regimes prioritize privacy but risk slower adoption; those embracing surveillance capitalism gain operational efficiency but face growing public skepticism.
