Yet, fragmentation persists: Germany's Solvent Fund, France's T2, and Italy's initiatives operate with varying speeds and access, complicating cross-border integration. Emerging economies face a dual challenge: accessing efficient payment systems while asserting financial sovereignty. In Africa, mobile money platforms like MTN Mobile Money and Orange Money have leapfrogged traditional banking, enabling SMEs to transact across borders with minimal friction. However, these systems often rely on SWIFT for international settlements, retaining exposure to foreign regulatory regimes. India's UPI, a real-time payment network, has processed over \$200 billion annually since 2022, but its international reach remains limited without cross-border interoperability.
