Traditional grammar curricula, rooted in Eurocentric models, failed to address the diverse linguistic backgrounds of learners, many of whom entered English classrooms with rich multilingual repertoires but were forced into monolingual paradigms. Pal and Suri emerged at this juncture not merely as linguists, but as cultural architects responding to a systemic disconnect: language instruction that ignored learners' first

languages, cognitive styles, and sociopolitical realities. Their research was profoundly informed by the cognitive sciences, sociolinguistics, and postcolonial theory. They drew on decades of studies showing that grammatical competence develops through exposure, pattern recognition, and meaning-making—not through rule memorization. This insight challenged the dominant pedagogy of the time, which treated grammar as a static, rule-bound code. Instead, Pal and Suri proposed a gradient model of grammatical knowledge—one that acknowledges variation, emergence, and the role of discourse context. Their work emphasized that English, as a global language, is not a fixed system but a living, evolving network of usage shaped by millions of speakers across time and space.

Longitudinal studies in Singapore and Brazil show improved performance in professional communication—particularly in cross-cultural settings—where learners adeptly navigate formal and informal registers. Yet, implementation challenges persist: teacher training lags, digital tools remain uneven, and standardized curricula resist fluid, context-sensitive approaches.

## Controversies and Cultural Resistance

The global rollout of Pal and Suri’s model has not been without friction. In several nations, their emphasis on linguistic diversity and rejection of monolithic correctness has sparked political and cultural pushback.
