Equally critical is the Code's role in energy equity. As electrification expands to underserved communities, standards must ensure access without compromising safety. Innovations like modular, low-cost microgrids—compliant with NFPA 70 but adapted for rural use—could redefine equitable electrification, turning compliance into empowerment. Governance of the Code itself may evolve. With growing calls for transparency, the NFPA is exploring open-source review platforms and real-time stakeholder feedback mechanisms. While preserving its
