Yet Ephesians diverges from Paul’s earlier letters by emphasizing cosmic themes over ethical exhortation, suggesting a late-stage theological maturation aimed at a diverse, multi-ethnic audience. This shift underscores Ephesus’s role not merely as a mission field, but as a theological incubator where Christian identity was forged in dialogue with the ancient world.
