The enabler’s calm facade masks internal dissonance, a psychological compartmentalization that prevents recognition of their own distress. This dual activation—dopaminergic reward in the caretaker, threat-based avoidance in the enabler—creates a self-perpetuating system. Each cycle of conflict and reconciliation strengthens neural pathways that prioritize relational continuity over individual health. Longitudinal studies show that individuals in codependent relationships exhibit

reduced gray matter density in the anterior cingulate cortex, a region linked to conflict monitoring and emotional regulation. This structural change correlates with lower tolerance for emotional ambiguity, making independent coping increasingly difficult. The absence of a formal diagnostic category in the DSM-5 reflects deep skepticism within mainstream psychiatry, where codependence is often dismissed as a symptom cluster rather than a distinct disorder. Critics argue that conflating behavioral patterns with clinical pathology risks over-diagnosis and pathologizes normal relational complexity. Yet, proponents counter that codependence represents a systemic failure of relational health—one that significantly elevates risk for anxiety, depression, and trauma-related disorders.
