The most pressing concern is accessibility: with preparation costs averaging 3,000 riyals and internet access uneven across regions, socioeconomic barriers threaten inclusivity. A 2023 study by the King Abdulaziz University Health Institute found that only 37% of applicants from rural governorates secured certification, compared to 62% in urban centers—a gap that risks perpetuating workforce inequity. Internationally, there is growing momentum to pursue ICM recognition, potentially enabling cross-border licensure and participation in global maternal health networks. Long-term, Prometric may serve as a model for other GCC states seeking to professionalize mid-level health roles. Its integration with digital health infrastructure also positions it at the forefront of telehealth readiness—preparing midwives to
