The geopolitical stakes intensified with the rise of TikTok, a Chinese-owned platform whose recommendation algorithm—optimized for addictive, short-form content—rapidly captured global youth. Concerns over data sovereignty, surveillance, and soft power influence led to bans in India, the U.S. military, and multiple European nations.
