Internally, editorial teams faced tension between scholarly openness and institutional caution. The 1983 re-issue of the 'Apocryphon of John'—a text once condemned by Irenaeus—required careful negotiation with reviewers, balancing historical interest with ecclesiastical sensitivities. Globally, the Penguin series sparked comparative reflections. In the United States, where evangelicalism dominated public discourse, the editions were seen by some as a corrective; by others, as an unnecessary softening of orthodoxy.
