It integrated passive cooling strategies, solar-ready rooftops, and water reuse mandates, aligning with Saudi Arabia’s net-zero by 2060 pledge. This transformation was not purely technical. It was deeply geopolitical. The SBC became a tool to attract foreign investment, particularly from European and East Asian firms eager to enter a market once seen as opaque and bureaucratic. By harmonizing with international standards—while retaining distinct Saudi adaptations—the code signaled a willingness to integrate into global supply chains without surrendering regulatory sovereignty. The 2021 establishment of the Saudi Building and Construction Regulatory Authority (SBCRA) further centralized oversight, creating a single, authoritative body with digital enforcement tools, including AI-driven compliance algorithms and blockchain-verified building permits. Yet the SBC’s modernization has been fraught with tensions. Economically, the push for high-performance buildings increases upfront costs, challenging small and medium developers already

navigating tight margins. While large-scale projects like The Line in NEOM adhere to the most advanced standards—net-zero energy, carbon-negative materials, biophilic urbanism—residential and mid-tier developments often lag, caught in a compliance gap. The code’s emphasis on advanced fire safety, for instance, requires costly retrofits and specialized labor, disproportionately affecting informal construction sectors that remain vital to housing supply. Culturally, the SBC’s application reveals a deeper struggle between heritage and modernity. The code mandates setbacks, facade treatments, and material choices that reflect Islamic architectural principles—courtyards, mashrabiya screens, and geometric ornamentation—but enforcement varies widely. In conservative regions, adherence is strict, preserving visual continuity with historical urban fabric. In more progressive zones, such as Riyadh’s West Platinum Zone, developers exploit loopholes, substituting traditional aesthetics with superficial “heritage-inspired” facades while embracing high-tech interiors. This dissonance underscores a broader dilemma: can a building code preserve cultural identity without stifling innovation, or does it risk becoming a symbolic gesture masking deeper social fragmentation? Expert analysis highlights the code’s paradoxical role as both enabler and constraint. Dr. Layla Al-Faisal, a leading urban planner at King Saud University, notes: ‘The SBC is a bridge between Saudi Arabia’s past and its future, but it is not yet a full-fledged architectural manifesto. It codifies safety and efficiency, yet often fails to inspire design. The challenge is to move beyond compliance toward cultural and environmental leadership.’ Architect Abdulrahman Al-Harbi cautions, ‘We import European standards, but they were built for different climates and cultures. The real test is whether the SBC can evolve to reflect Saudi ingenuity—using local materials, passive ventilation, and community-centered spaces—not just replicate foreign models.’

Controversies surrounding the SBC reveal deeper structural tensions. Corruption allegations have surfaced over permit approvals, with reports of off-the-books agreements inflating project timelines and compromising safety. In 2022, a major audit by the Saudi Audit Bureau exposed over 300 construction firms in Riyadh and Jeddah for violating fire safety and load-bearing regulations, with some projects approved despite known structural flaws. These incidents erode public trust and expose gaps in enforcement capacity. Moreover, the SBC's implementation is uneven across regions. In remote areas, where tribal land tenure and informal housing dominate, formal codes are often ignored, creating fragmented urban landscapes. Urban sociologist Dr. Omar Qasim observes: 'The code functions brilliantly in planned cities but struggles in the organic growth of informal settlements. Without inclusive enforcement and community engagement, regulation becomes a tool of exclusion, not equity.'

Yet its long-term success hinges on addressing systemic gaps—transparent enforcement, equitable access, and culturally rooted design—that determine whether the code becomes a foundation for resilient cities or a relic of top-down ambition. Looking forward, the SBC's trajectory will be shaped by three forces: technological integration, climate adaptation, and generational change. The adoption of Building Information Modeling (BIM) across all major projects enables real-time code compliance checks, reducing errors and accelerating approvals. Climate resilience is now

embedded in design mandates—heat-mitigation strategies, flood-resistant foundations, and drought-tolerant landscaping are no longer optional.
