Meanwhile, deep-sea exploration missions—using remotely operated vehicles equipped with bio-inspired cameras—are rediscovering eye adaptations in previously unexplored species, from bioluminescent lanternfish to abyssal anglerfish. The long-term trajectory suggests a convergence: ecological monitoring, technological innovation, and ethical stewardship, all anchored in the quiet insight that to understand fish eyes is to understand the web of life itself. Lois Ehlert’s work, born in the post-war era of scientific optimism, now stands as a fulcrum—balancing wonder with responsibility, knowledge with justice, and nature’s designs with humanity’s choices.
