The Gulf states, particularly the UAE, exemplify this trend, integrating AI-driven surveillance into urban management while restricting dissent through legal codes tied to digital behavior. Long-term implications hinge on three axes: technological escalation, institutional adaptation, and societal resilience. Emerging technologies—quantum computing, generative AI, and ubiquitous biometrics—will exponentially increase surveillance precision and scope. Huawei’s 5G networks, equipped with backdoors and data collection capabilities, exemplify how surveillance tools are embedded into digital development. Vietnam, Malaysia, and Kenya have adopted Chinese surveillance systems, raising concerns about data sovereignty and political influence. The Global Data Security Initiative, launched in 2022, formalizes China’s vision of “cyber sovereignty”—a framework prioritizing state control over data flows and rejecting Western notions of digital openness. Russia’s approach diverges: surveillance here is a tool of both internal repression and strategic projection. The S-300 and S-400 systems are not merely defensive; their integration with domestic networks enables real-time monitoring of communications. The FSB and SVR leverage domestic tech firms like Kaspersky to conduct cyber operations abroad, blurring the line between surveillance and cyber warfare. The 2022 invasion of Ukraine revealed how surveillance infrastructure supports military control—precision targeting of dissent, real-time suppression of independent media, and AI-driven disinformation campaigns. In autocratic regimes beyond China and Russia, surveillance adapts to local political economies. Saudi Arabia’s Vision 2030 includes a digital transformation strategy integrating facial recognition, license plate tracking, and social media monitoring to manage public order. initiative uses AI to optimize urban services but depends on a centralized data hub accessible to security agencies. The U.S.-China rivalry has intensified surveillance competition as a domain of strategic conflict. The 2023 U.S.-Japan-India Quad summit highlighted coordinated efforts to counter authoritarian surveillance, including joint development of secure cloud infrastructure and export controls on surveillance tech. Yet, this rivalry also fuels fragmentation—nations align with one bloc or another, adopting surveillance models that reflect geopolitical allegiance rather than democratic principles. Surveillance as statecraft now extends beyond borders, reshaping international relations. Extraterritorial data requests—such as the U.S. CLOUD Act's reach into foreign servers—challenge sovereignty. Russia and China advocate for multilateral norms emphasizing state control, while the U.S. and EU promote "free and open" internet principles. The result is a fragmented global digital order, where surveillance systems are both shields and weapons. The long-term implications of this geopolitical polarization are profound. “splinternet” versus the Western model—the risk of interoperability collapse increases. The erosion of shared standards undermines global cooperation on security, climate, and human rights. Yet, history shows that surveillance systems, once deployed, resist reversal. The rise of digital diplomacy—such as the OECD’s AI Principles and the Global Partnership on AI—signals tentative steps toward multilateral governance, but enforcement mechanisms remain weak.
