In an environment where clicks and ad impressions dictated success, such patience became a liability. The tension between depth and velocity intensified as cable news, particularly Fox News (founded 1996), began to dominate the airwaves—prioritizing immediacy, partisanship, and emotional resonance over extended inquiry. McDougal's response was to double down on brand authority, positioning "Crucible" as a trusted counterweight to what he saw as the trivialization of news.
