Long-term implications hinge on whether the global financial architecture can transcend jurisdictional balkanization. The rise of digital nomadism, decentralized finance (DeFi), and crypto-assets threatens to further decentralize control, enabling capital to bypass traditional banking and regulatory gatekeepers. Yet this same innovation offers tools for accountability: artificial intelligence in transaction monitoring, decentralized identity verification, and cross-border data sharing platforms. The future may see a hybrid regime—sovereign jurisdictions retaining some autonomy, but operating within a transparent, data-rich global financial ecosystem. For policymakers, the imperative is clear: sovereignty must be redefined not as financial opacity but as fiscal responsibility.
