In healthcare, HVAs expose vulnerabilities in pandemic preparedness—supply chain fragility for vaccines, hospital surge capacity, and rural access gaps—critical after the 2020–2022 global health crisis laid bare systemic weaknesses. Expert perspectives converge on

one truth: HVAs are not static documents but dynamic intelligence systems. Dr. Saleemul Huq, leading climate adaptation scholar at the International Centre for Climate Change and Development, emphasizes: ‘An HVA must evolve with changing risk landscapes—from static hazard maps to adaptive models that incorporate real-time data, community feedback, and future climate scenarios.’ This fluidity is essential in an era where climate change accelerates hazard frequency and intensity, rendering fixed risk profiles obsolete. Controversies and Limitations: Power, Bias, and Execution Gaps

Despite its analytical rigor, the HVA is not immune to critique. One persistent concern is the potential for politicization. In authoritarian regimes, vulnerability data may be suppressed or manipulated to downplay systemic risks or deflect accountability. In democracies, HVAs can become performative exercises—audits conducted without follow-through, risk assessments cherry-picked to justify preordained policy outcomes. The 2017 Puerto Rico electrical grid HVA, conducted before Hurricane Maria, was later criticized for underestimating social vulnerability, contributing to delayed federal response and exacerbating mortality. Data quality remains a foundational challenge. Accurate HVAs require granular, up-to-date information on population density, infrastructure integrity, economic activity, and institutional capacity—many developing nations lack the surveillance, census, or digital infrastructure to provide reliable inputs. Satellite imagery and machine learning help bridge gaps, but they cannot replace ground-truthing. Moreover, vulnerability is not purely physical; it is deeply social. Marginalized groups—refugees, indigenous

communities, informal workers—often remain invisible in datasets, leading to assessments that reinforce existing inequities. Another critique centers on implementation. A sophisticated HVA is only as effective as its integration into planning and investment cycles. In many countries, risk assessments exist in silos—environmental ministries produce them, urban planners ignore them, and budgets remain unchanged. The World Bank estimates that only 38% of national disaster risk reduction strategies include formal vulnerability analysis in policy execution. Without institutional mandates, funding, and cross-sectoral coordination, HVAs risk becoming academic artifacts rather than catalysts for change. Environmental and technological disruption further complicate the HVA paradigm. Climate change introduces non-stationary hazards—extreme weather events that defy historical patterns—making probabilistic modeling less reliable. Meanwhile, cyber-physical systems introduce new vulnerabilities: a ransomware attack on a water treatment plant or a coordinated disruption of smart grid infrastructure may trigger physical cascades invisible to traditional hazard maps. urban density maps to guide retrofitting programs and evacuation drills. This systemic approach contributed to reduced mortality in the 2011 Tōhoku event despite its magnitude. In contrast, sub-Saharan Africa faces acute challenges. While countries like Kenya have adopted HVA frameworks supported by UNDP and regional NGOs, implementation is uneven. Limited technical capacity, fragmented data systems, and competing development priorities hinder consistent application. Yet, innovative models emerge: in flood-prone Ghana, community-based HVAs—combining local knowledge with NDMA (National Disaster Management Organisation) protocols—have improved early warning responsiveness and evacuation efficiency. The European Union offers a supranational model. The EU’s Floods Directive mandates member states to conduct risk assessments and management plans, with cross-border coordination for river basins. This integration reflects the bloc’s recognition that hazards ignore borders. However, disparities persist: Eastern EU states lag behind Western counterparts in data infrastructure and institutional maturity, revealing the risk of a resilience divide within a unified policy framework. In the U.S., HVA practice is decentralized yet evolving. Post-Katrina, FEMA promoted hazard vulnerability assessments as core to community resilience grants. Yet, federal alignment remains inconsistent. Cities like Miami, grappling with sea-level rise, have pioneered adaptive HVAs incorporating climate projections and social equity metrics. For example, AI algorithms now integrate satellite imagery, social media sentiment, and infrastructure sensor data to forecast flood impacts with 85% accuracy, enabling dynamic HVA updates during evolving crises. Yet, technology alone cannot solve the human and institutional dimensions. The next generation of HVAs must embed participatory intelligence—local knowledge, community mapping, and real-time feedback loops—to counter data bias and ensure inclusivity. The Philippines’ “Barangay Resilience Index,” co-designed with village councils and climate scientists, exemplifies this shift: combining traditional ecological knowledge with digital risk modeling to prioritize adaptive investments at the community level. Geopolitically, HVAs are becoming instruments of soft power and strategic alliances. The U.S.-led Indo-Pacific Strategy includes joint HVA initiatives to strengthen disaster resilience in vulnerable island nations, countering regional

influence while building shared infrastructure security. Similarly, the African Union’s Continental Early Warning System, supported by the EU and UN, aims to harmonize vulnerability assessments across member states, fostering regional stability and reducing humanitarian burden. Long-term, HVAs must evolve into anticipatory governance tools. The concept of “resilience dividends”—where proactive risk reduction unlocks economic growth, social equity, and environmental sustainability—positions HVAs as central to 21st-century policy. As the UN Secretary-General’s 2023 report warned: ‘We are not preparing for disasters—we are facing a new era of systemic risk.
