In fragile states, violence often serves resource access—mineral extraction in the DRC, oil routes in the Niger Delta—where armed groups, foreign investors, and corrupt officials co-create a violent equilibrium. In liberal democracies, the recipe manifests through institutional inertia and legal evasion: pharmaceutical companies suppressing drug risks, defense contractors inflating costs under the guise of national security, tech giants monetizing behavioral manipulation with minimal accountability. The globalized economy amplifies this: supply chains become invisible conduits for exploitation, where labor abuses in Southeast Asia feed fast fashion in Europe, and toxic waste from developed nations pollutes developing regions—all under layers of shell companies and offshore jurisdictions. Economic incentives are the driving force. The “profit imperative” does not merely motivate criminal acts; it drives the design of systems that produce harm as a byproduct—or worse, as a feature.
