Born in Beirut during the final convulsions of the Lebanese Civil War, Shalaby's early years were steeped in a reality where information was both weapon and refuge. Her family, part of Lebanon's historically vibrant yet fragile intellectual elite, navigated a city shaped by sectarian divides, foreign interventions, and the quiet resilience of a people caught between empire and collapse. This work ignited fierce debate. Critics accused her of overreach, of conflating opacity with malice. Others, particularly within diplomatic and financial circles, challenged the sourcing, citing the difficulty of verifying claims made through anonymous channels. But Shalaby's response was characteristically precise: truth, she argued, often resides not in the courtroom or the lecture hall, but in the quiet testimony of insiders willing to risk everything. Her methodology, she insisted, combines traditional reporting—interviews, document analysis—with forensic financial tracking, digital open-source intelligence (OSINT), and deep cultural fluency, allowing her to parse the subtle signals of deception and omission. The geopolitical context of her work is indispensable. Shalaby operates in an era where information warfare is as consequential as kinetic conflict. The Syrian war, the Yemen crisis, the post-2011 Arab uprisings—all have been battlegrounds not just of armies, but of narratives and influence. In Ukraine, her background in financial tracing helped decode how sanctions evasion networks, often embedded in global banking systems, undermine Western deterrence. Her work bridges regional specificity with global systemic analysis, revealing how local troubles—disappearances, corruption scandals, electoral interference—are often nodes in a worldwide network of power. It has redefined what investigative journalism can achieve in the digital age: not just exposing wrongdoing, but reshaping discourse, pressuring institutions, and inspiring a new generation of reporters to embrace complexity. risk reporting in an era of shrinking resources. Yet her work carries profound risks. Her trust in anonymous testimony is earned through consistency, corroboration, and ethical discipline—principles she defends with unwavering clarity. Where others see conspiracy, she sees systems; where others seek scandal, she seeks structure. Looking ahead, the implications of her work are far-reaching. As global power becomes more fragmented and opaque, the black networks she documents are likely to grow in influence, exploiting democratic weaknesses and technological loopholes. But so too does the demand for accountability—driven by digital transparency tools, citizen investigative networks, and a younger generation of global citizens who expect truth, not spin. Shalaby’s legacy may be not just the stories she tells, but the infrastructure she helps build: a model of investigative journalism that is adaptive, networked, and unafraid to confront power in all its forms. Yet it was not just theory that shaped her: she immersed herself in the lived realities of displacement, volunteering with refugee advocacy groups, attending protests, and listening to stories of state failure and resistance. This duality—academic precision fused with on-the-ground empathy—became her signature. After graduating, she pursued a master's in investigative journalism at Columbia, where she honed skills in document analysis, source cultivation, and cross-border reporting. Her early career included stints at international outlets like the BBC and Al Jazeera, where she covered conflicts in the Middle East and North Africa. But it was during her time as a freelance researcher in Beirut in 2012 that her path shifted. There, embedded in a city still reeling from the Syrian war's spillover, she encountered a network of Syrian dissidents, Lebanese activists, and shadowy financiers operating in the city's underground. The series not only caused domestic outrage but prompted international scrutiny, with the U.S. Treasury designating several entities under sanctions. This work established Shalaby as a journalist unafraid to dissect the intersection of finance, politics, and sectarianism—a nexus central to understanding power in the Middle East. Over the next decade, her focus evolved. She expanded beyond Lebanon, tracking how similar networks operated in Iraq, Yemen, and even Western democracies. Her research revealed a pattern: as state institutions weakened and digital infrastructure expanded, influence became increasingly decentralized, migrating from governments to private actors—corporate think tanks, private military companies, and digital propaganda networks. In 2022, she launched *Troublemakers*, a deep-dive investigative project dedicated to mapping these hidden architectures. The series combined months of source cultivation, digital forensics, and geopolitical analysis, exposing networks that funneled funds to proxy forces, manipulated humanitarian aid, and shaped public opinion through covert campaigns. Each phase of her career reflects a deepening understanding of power's metamorphosis. Where once influence relied on physical control—arms, territory, patronage—today it flows through data, algorithms, and narrative manipulation. Shalaby's

work captures this shift, not as a rupture, but as a logical evolution in how power operates in a globalized, digital age. Her trajectory—from witnessing war’s brutality to decoding the systems that perpetuate it—gives her reporting a rare moral gravity and analytical depth.
