However, disparities remain: Eastern European nations lag in laboratory access and teacher training, prompting EU-wide initiatives like the ChemEdX Europe network to distribute open-access resources and professional development. Emerging economies face a dual challenge: building capacity while navigating geopolitical alignment. India's National Science Policy 2023 identifies chemistry benchmarking as critical to its 'Make in India' agenda, pushing for digital labs and teacher training in underserved regions. Yet, data sovereignty concerns—especially over student performance metrics stored in foreign cloud systems—have slowed full adoption. Brazil, leveraging its strengths in tropical chemistry and bioproducts, has partnered with IUPAC to localize benchmark

content, emphasizing region-specific challenges like deforestation chemistry and sustainable agriculture.

Industry Impact: From Laboratories to Market Realities

In low-income countries, limited laboratory access and unreliable internet connectivity hinder participation. Similarly, in parts of South Asia, gender disparities persist—girls’ enrollment in advanced chemistry tracks lags, reflecting broader societal barriers. Latin America presents a mixed picture. Brazil’s investment in regional chemistry networks has boosted performance, particularly in sustainable chemistry and environmental monitoring. However, political volatility and uneven funding create instability, undermining long-term progress. In Mexico, public-private partnerships with energy firms
