In sub-Saharan Africa, for instance, informal healthcare workers—often excluded from formal training programs—face disproportionately high exposure risks. A 2021 study in Nigeria found that only 12% of rural clinics provided annual bloodborne pathogen training, compared to 85% in urban hospitals. This disparity is not just logistical; it is structural, rooted in decades of underinvestment in public health infrastructure. International organizations like the WHO and ILO have sought to bridge this gap. The ILO’s “Occupational Safety and Health in the Informal Economy” initiative promotes

flexible, community-based training models tailored to local realities.
