Scandals involving inappropriate behavior—such as the 2019 fallout involving Yannick Nézet-Séguin—reveal how personal conduct becomes inseparable from professional legitimacy. These cases expose the high stakes of performance, where the conductor's persona amplifies every misstep, transforming private failings into public crises.
