In the East, Syriac and Coptic versions retained distinct linguistic and theological nuances, reflecting the region's theological schools and cultural idiom. In the West, Latin translations became instruments of both unity and control, embedding the creed within the institutional machinery of the Roman—and later Holy Roman—empires.
