Edelman acknowledges these constraints, advocating for context-sensitive, trauma-informed applications rather than universal templates.

Looking ahead, Edelman's vision points toward a new paradigm: cognitive resilience as a cornerstone of global stability. She projects that by 2035, nations investing in widespread cognitive literacy—through education, public discourse, and policy—will outperform peers not only economically, but in social cohesion and adaptive capacity.
