Second, the digital expansion, while expanding reach, introduces cybersecurity threats. Electronic copies stored

in cloud systems managed by private vendors raise concerns about data privacy, especially when patient data is used in training algorithms without transparent consent. Third, the manual's commercial embedding risks marginalizing open-access alternatives. Despite calls for open-source medical repositories, proprietary licensing restricts free access, reinforcing global inequalities in knowledge distribution. Comparatively, Western medical compendia such as *UpToDate* or *StatPearls* dominate high-income countries but often remain inaccessible or irrelevant in low-resource settings due to cost and language barriers. Climate change is amplifying health risks globally, from vector-borne diseases to heat-related mortality, requiring medicine to evolve beyond acute care into predictive and preventive paradigms.
