The Lair's economic impact extended beyond theft. By enabling large-scale capital flight, it distorted local economies: in countries like Nigeria and Argentina, where illicit outflows exceeded legitimate foreign investment, financial instability intensified, inflation spiked, and public trust in institutions eroded. Multinational corporations, too, found themselves complicit—some unwittingly channeling funds through Gryphon nodes, others exploiting the opacity to minimize tax obligations through transfer pricing and profit shifting.
