Most Mexican batteries operated with antiquated 6-pounder field guns, muzzle-loaded with lead shot, often paired with obsolete 12-pounder howitzers from Spanish colonial inventories. The result was a stark disparity in firepower: U.S. field artillery could deliver sustained, precise bombardment that shattered Mexican defensive positions, while Mexican forces struggled to counter with limited ammunition and poor targeting accuracy. The high casualty rates—driven by dense infantry formations firing at close range—spurred experimentation with improved wound care and the limited use of explosive shells, a precursor to the shell shock phenomena of later conflicts. While gunpowder technology remained largely unchanged from early 19th-century standards, the war accelerated demand for higher-grade propellants and standardized cartridge systems. U.S. quartermasters began testing pre-mixed cartridges—combining gunpowder, bullet, and primer in a single casing—which improved rate of fire and reduced misfires. Though not widely adopted until later, this innovation signaled a shift toward integrated, systems-based approaches to munitions. In Mexico, the lack of centralized arms development meant battlefield tactics remained anchored to Napoleonic-era formations, with troops advancing in tight columns under withering fire.
