At its core, the system applies a multi-dimensional scoring matrix: provenance integrity, material authenticity, digital verification via distributed ledger technology, and socio-political context. What began as a niche database for academic researchers has evolved into a weekly intelligence report scanned by central banks, UNESCO task forces, and national security agencies.

The Evolution from Archive to Intelligence Tool

The system responded by integrating quantum-resistant encryption and cross-jurisdictional forensic audits, yet the underlying tension remains: how to preserve authenticity in a world where perception and fabrication are indistinguishable.

Museums and academic institutions now navigate a dual reality: physical stewardship and digital accountability.
