For instance, Lucifer’s 2013 “Balkan Voices Initiative” was framed as a project to support independent journalism in post-conflict states. However, internal communications revealed that the initiative was co-funded by the European Union’s cultural division, with explicit mandates to promote narratives favorable to Euro-Atlantic integration.
