Her research at Harvard shows that teams with high psychological safety outperform low-safety counterparts by 20–30%, particularly in high-stakes environments like healthcare and tech. Edmondson advocates for “speaking up” rituals and leader vulnerability as key interventions. “Leaders must model uncertainty,” she advises. “When you say, ‘I don’t know, but let’s figure it out together,’ you create space for innovation.” Richard Harrison, a pioneer in generational workforce dynamics, highlights the need for OB frameworks that reflect evolving employee expectations. “Millennials and Gen Z prioritize purpose, growth, and flexibility,”

he notes. “Firms that cling to rigid hierarchies and annual reviews risk losing the most engaged talent. Agile coaching, micro-learning, and career pathing are no longer nice-to-haves—they’re survival tools.” Yet resistance to OB persists. Some executives view culture initiatives as “soft,” measuring success only through lagging indicators like revenue. Others misunderstand OB as manipulation—using psychology to nudge compliance rather than empower. This skepticism is not without foundation: past misuse of behavioral science in surveillance or coercion underscores the ethical imperative for transparency and integrity in OB practice.
