A 2020 OECD report flagged over 300 certification firms globally, with significant variation in auditor competence and audit depth. This fragmentation risks creating a false equivalence—where certification becomes a generic seal rather than a meaningful indicator of competence. In 2018, a German court ruled in a product liability case that a manufacturer’s ISO 9001 noncompliance constituted negligence, setting a precedent that could reshape enforcement.
