Though quickly debunked, the incident exposed the fragility of historical authenticity in the digital age. It also signaled the emergence of Gandhi Kahani as a contested narrative: a symbol both revered and weaponized. Media theorist Dr. Meera Desai explains: “Gandhi’s image operates as a kind of cultural cipher—its meaning is not fixed but negotiated through repetition, context, and technological mediation. Each digital iteration refracts his legacy through new lenses of power, resistance, and identity.” This process is accelerated by AI tools: generative models can now superimpose Gandhi’s face onto historical footage, create synthetic speeches in his voice, or fabricate “new” moments of moral clarity. These images, though synthetic, carry the authority of authenticity—exploiting trust in visual evidence to shape perception. The implications are profound. As Dr. Rajiv Malhotra observes, “When a symbol of nonviolence is weaponized to legitimize surveillance, censorship, or authoritarian control, the very ethos it represents is subverted. The initiative partners with universities in Africa, Latin America, and Southeast Asia, distributing curated digital editions of Gandhi’s works alongside AI-powered translation tools. These efforts aim to reframe Gandhi not as a relic of Indian history, but as a transnational philosopher whose ideas remain relevant to 21st-century challenges. Yet this projection is not without friction. In countries with strong anti-colonial or socialist legacies—such as South Africa, where Mandela remains a towering symbol—Indian efforts to elevate Gandhi risk being perceived as cultural appropriation or neocolonial narrative imposition. Activists in Kenya and Nigeria have critiqued the selective emphasis on Gandhi’s Hindu identity, arguing that his

broader message of pluralism and justice resonates more deeply than his religious affiliations. Moreover, in an era of digital sovereignty, nations are asserting control over historical narratives. China's promotion of Confucius as a state-sanctioned moral guide contrasts with India's decentralized, pluralistic approach—yet both reflect a shared recognition: cultural symbols are strategic assets.
