In Japan, the legend of the warrior Tomoe Gozen—sometimes described as “tall and bold”—reflects different cultural values, where height symbolized martial virtue but within a communal ethos absent in Geronimo’s solitary resistance. Looking forward, the question “how tall was Geronimo?” remains less about a single number and more a lens into deeper structural issues. As digital humanities advance, machine learning and AI-driven archival analysis may refine historical estimates, yet the ethical imperative remains: to contextualize, not quantify.
