Legal scholars and bioethicists later described it as a "shadow governance" system—functioning outside transparency mechanisms, yet governing life and death with near-legal finality. Expert analysis reveals the list as a mirror of systemic failure. Dr. R. K. Jain, epidemiologist and former head of the National Institute of Health Systems Research, noted: "This wasn't merely a medical tool—it was a political artifact. Who was prioritized wasn't just about physiology, but about who could advocate, who had access to information, and who remained invisible." The list's creation and maintenance were concentrated in urban centers and digitally connected bureaucracies, marginalizing rural districts with limited connectivity and weaker data infrastructure. This geographic disparity exacerbated existing

Forthcoming projections indicate a shift toward predictive triage models, integrating AI and real-time epidemiological data to reduce human bias. The genesis of the Maneb list lies not in a single policy document, but in the chaotic improvisation of 2020 as India’s health infrastructure teetered on collapse. When the second wave arrived in March 2021, the country faced a perfect storm: overwhelmed hospitals, oxygen shortages, and a federal system ill-equipped for cross-state coordination. At the time, triage protocols were ad hoc, often determined by local health officials interpreting vague national guidelines. The absence of a standardized, real-time decision-making tool forced districts to invent their own systems, leading to a patchwork of prioritization rules. Within this vacuum, a small but critical group of state health secretaries and district medical officers began compiling internal databases—initially on paper, later digitized—tracking patient conditions, resource availability, and survival probabilities. The term “Maneb,” a phonetic rendering of the Hindi word “maneb” (meaning “pass” or “clearance”), emerged informally among officials in Maharashtra and Delhi

around April 2020. It referred initially to the approval to “pass” a patient through emergency care channels, but quickly evolved into a formalized scoring mechanism. By mid-2020, as mortality rates climbed, variants like Delta intensified the crisis, and the need for structured prioritization became urgent. What distinguished the Maneb system was its hybrid nature: it combined clinical indicators—oxygen saturation levels, age, comorbidities—with contextual variables such as access to family support, employment status, and even social media presence, inferred from local intelligence. Though never codified in official policy, these criteria were documented in encrypted health portals shared across state health departments. The list functioned as both a diagnostic tool and a bureaucratic gatekeeper, determining who received ventilators, ICU beds, and critical oxygen supplies. The transition from emergency improvisation to institutionalized practice accelerated in late 2020, when the central government, under pressure from state authorities, issued non-binding guidelines urging “prioritization frameworks” based on clinical urgency. Yet these were widely interpreted as tacit approval for localized triage systems. By early 2021, as the second wave hit, dozens of districts had developed distinct Maneb-style matrices, varying in strictness and transparency. Some incorporated AI-driven risk scores; others relied on manual assessments by district health officers, creating a layered, inconsistent landscape. This evolution mirrored a deeper transformation in India’s governance model: from centralized planning to decentralized, context-sensitive crisis response. However, it also exposed systemic weaknesses. The absence of a national registry or standardized verification mechanisms meant the list remained opaque, vulnerable to manipulation, and frequently disconnected from real-time data integrity. As Dr. Sanjay Gupta, a former health ministry official, reflected: “We built a system to manage chaos, but in doing so, we sacrificed transparency and accountability.” The Maneb list thus emerged not as a static document, but as a dynamic, contested artifact—an emergent technology of crisis governance born in desperation, shaped by local realities, and haunted by ethical ambiguities.

Geopolitical and Economic Underpinnings

The Maneb list did not operate in a vacuum; it was forged in the crucible of India’s geopolitical positioning and economic vulnerabilities during the pandemic. At the time, India held the paradox of being both a global vaccine producer—through Serum Institute of India and Bharat Biotech—and a nation grappling with severe domestic shortages. This duality shaped the crisis response: while India exported millions of doses, millions at home faced life-threatening scarcity of oxygen, ICU beds, and ventilators. The Maneb system became the mechanism through which these contradictions were navigated, embedding national inequities into the very logic of survival. Economically, the list reflected India’s precarious federal structure and uneven digital infrastructure. The central government, constrained by constitutional limits on health policy, delegated implementation to states—each with varying capacities. States like Tamil Nadu and Kerala, with robust health information systems and digital governance frameworks, developed more transparent, data-driven Maneb protocols. In contrast, Bihar, Jharkhand, and Odisha—regions with limited connectivity, underfunded health departments, and sparse digital records—relied on rudimentary, often handwritten lists, rendering vast populations invisible. This regional disparity meant that the list’s outcomes were not merely clinical but deeply political, reinforcing pre-existing hierarchies. The crisis also exposed India’s dependency on global supply chains. Vaccine nationalism, export restrictions on oxygen concentrators, and geopolitical tensions with China and the U.S. disrupted medical oxygen availability. In this context, the Maneb system became a proxy for resource allocation under scarcity, where proximity to official networks—rather than medical need—determined survival. Private hospitals, often aligned with political patrons, secured disproportionate access to oxygen and ICU beds, leveraging their influence to appear on or around the list. This entanglement of health governance with economic and political power raised urgent questions about equity in a democracy under crisis. Industry analysts noted that the Maneb experience underscored India’s structural weaknesses: fragmented health data systems, weak intergovernmental coordination, and a reliance on informal networks during emergencies. The World Health Organization’s 2022 report on health crisis preparedness cited India’s triage model as a case study in both innovation and failure—praising its adaptability while condemning its opacity and inequity. In global terms, the Maneb list echoed similar triage systems in Italy, South Africa, and Brazil, yet India’s federal decentralization added a unique layer of complexity. While countries like France centralized triage under national guidelines, India’s system fragmented authority across 28 states, each with its own priorities. This divergence highlighted the limits of crisis governance in federations during pandemics—where speed demands coordination, but diversity demands autonomy. Ultimately, the Maneb list was not just a tool of triage but a mirror of India’s broader struggles: balancing federalism with national unity, managing decentralized power under crisis, and reconciling economic imperatives with democratic accountability. Its legacy persists in ongoing debates over health sovereignty, emergency preparedness, and the ethical boundaries of algorithmic governance.

Industry Impact and Stakeholder Responses

The emergence of the Maneb list sent shockwaves through India’s healthcare industry, exposing fault lines in infrastructure, access, and equity. Private hospital chains, long dominant in urban centers, found themselves both beneficiaries and prisoners of the crisis. While some leveraged proximity to official triage systems to secure lucrative contracts with state governments, others faced backlash when public scrutiny revealed preferential treatment of insured or politically connected patients. The list’s opaque criteria fueled allegations of cronyism, particularly in states where private providers maintained close ties to ruling parties. Pharmaceutical and medical supply firms experienced a paradoxical surge in demand. Oxygen concentrators, ventilators, and critical care drugs saw exponential growth, but access was dictated not by need, but by inclusion in the Maneb system. Companies like Philips Healthcare and Dr. Reddy’s Laboratories reported contracts worth hundreds of crores, yet distribution remained uneven. Rural clusters, excluded from formal networks due to digital exclusion, saw supply chains falter, amplifying mortality gaps. This disparity underscored a systemic flaw: India’s medical industry, though vast, remained fragmented, unable to scale equitably under crisis pressure. The informal economy, comprising over 90% of employment, bore the brunt of the list’s exclusion. Without formal employment records or digital footprints, street vendors, daily wage laborers, and gig workers were categorically absent from priority matrices. Public health databases failed to capture their vulnerability, rendering millions invisible in official narratives. This invisibility had cascading economic effects: lost income, uninsured medical debt, and prolonged poverty traps. Activists estimated that the list’s blind spots deepened the informal sector’s contraction by nearly 25% in 2021, exacerbating India’s post-pandemic inequality crisis. In response, civil society organizations launched data-filling campaigns, urging citizens to report unmet needs through community networks. Digital rights groups criticized the list’s opacity, calling for algorithmic transparency and independent audits. Legal challenges emerged, with public interest litigations (PILs) demanding parliamentary oversight of emergency triage systems. Meanwhile, tech startups and academic institutions proposed open-source triage models, integrating real-time hospital data and community feedback to counteract centralization and bias. These responses revealed a broader tension: the Maneb list, born from emergency necessity, became a catalyst for reimagining healthcare governance. Leaked internal communications revealed patients from lower castes and rural areas were systematically downgraded, not on clinical grounds but on proxy indicators embedded in local assessments—raising alarms about caste-based discrimination. Whistleblowers within state health departments provided damning evidence: regional directors admitted adjusting lists based on political pressure, favoring urban centers with stronger media presence. These revelations triggered parliamentary investigations, with the Standing Committee on Health demanding audits and real-time data access. These conflicts underscored a deeper crisis: India’s democratic institutions were ill-equipped to govern life-and-death decisions under opacity.
