In Pakistan, where literature is often politicized, **Broken** sparked heated debates: Was it authentic, or did it betray the nation’s suffering through a diasporic lens? Shamsie countered that her perspective was not external, but layered—born from decades of immersion in Pakistan’s story, however fraught. She emphasized that her role was not to judge, but to witness: “To write from the margins is not to speak for, but to amplify.” This duality—personal yet universal, local yet global—has cemented **Broken**’s place in contemporary literature.
