But we must resist the temptation to universalize Western cognitive models onto diverse populations. Language, education, and cultural norms shape cognition in ways that standardized tests often miss. Without cultural adaptation, assessments risk misdiagnosis and reinforce systemic inequities.” El-Asher’s research highlights the urgent need for locally validated tools and training, ensuring that neuropsychology serves, rather than silences, marginalized voices.

Dr. James Holloway, a neuroethicist at the University of Oxford, confronts the moral dimensions of neuroassessment: “The brain is not a passive organ to be measured—it is the seat of identity, agency, and meaning. As we deploy AI-driven neurocognitive systems, we must ask: Who benefits? Who is surveilled? Who is excluded?
