He saw the *Noli* not as a call to arms alone, but as a mirror—reflecting the rot of a system that dehumanized Filipinos while enriching Spain and a Creole elite complicit in exploitation. The novel’s publication in 1887 marked a turning point. It did not merely expose abuses like the abuse of *fuero* (legal privileges for Spaniards) or the corruption of *caciques* (local elites), it redefined the Filipino self-

conception. For the first time, native characters—like Crisostomo Ibarra and Simoun—were not victims or dimwits, but agents of change, flawed yet resolute. This narrative reclamation was revolutionary. It transformed abstract grievances into a shared moral imagination. The **Noli** became a cultural touchstone, widely circulated among mestizos, **ilustrados**, and even sympathetic Spaniards, sowing the seeds of a unified national consciousness.
