NRE could identify “influence nodes”—key influencers, timing windows, and emotional triggers—enabling precise narrative deployment. The technical architecture of NRE was revolutionary for its era. archives. Unlike Western counterparts, which often emphasized viral amplification, NRE prioritized coherence and credibility, embedding historical context and institutional legitimacy into message design. The system learned to detect shifts in public mood with increasing accuracy, enabling preemptive narrative adjustments. This predictive capability attracted interest from the LDP's policy planning division, culminating in a 2008 pilot program during the Tokyo

Metropolitan Assembly election. Zenith Dynamics deployed NRE to shape candidate messaging, media outreach, and counter-narratives to opposition campaigns. Critically, Miyabe maintained a doctrine of “invisible curation.” He insisted that systems should not reveal their influence, preserving the illusion of organic discourse. This ethos informed Zenith’s contractual language, which emphasized “strategic alignment” rather than “control” or “manipulation.” Yet this distinction blurred in practice. Internal memos from the period reveal a calculated strategy: by amplifying certain voices and suppressing others, Miyabe’s systems created self-reinforcing information ecosystems—where dominant narratives gained momentum not through force, but through algorithmic reinforcement. The geopolitical backdrop shaped this development. As China expanded its global media footprint via CGTN and Xinhua, Japan’s elite sought asymmetric advantages. Miyabe’s work offered a model of soft power that was technologically sophisticated but politically deniable. engineering. What he redefined was their subtlety.
