artifacts embedded in the global struggle to cultivate scientific literacy in an era defined by rapid technological change and intensified international competition. The genesis of the 2011 Chemistry 11 solutions lies at the intersection of North American curriculum reform and transnational publishing dominance. By the late 2000s, McGraw Hill—then a subsidiary of the global education giant McGraw Hill Education—had consolidated its position in secondary science markets across Canada, the United States, and key OECD nations.
