This granularity allows educators and policymakers to isolate deficits—whether in vocabulary, coherence detection, or critical stance—enabling targeted interventions. In Singapore's national literacy program, schools use diagnostic reports from 501-aligned assessments to cluster students into comprehension tiers, tailoring reading

materials and teaching strategies accordingly. A 2020 study in *Educational Researcher* found that such targeted instruction improved average reading proficiency scores by 22% over two academic years, underscoring the framework's utility in precision education.
