"We're caught between holistic understanding and institutional demand," notes Dr. Amara Nkosi, a neuropsychologist in Nairobi. "The Handbook helps bridge this gap, but systemic change requires policy reform, not just individual effort."

The controversy extends to assessment technology. AI-driven tools, often promoted as objective and scalable, face scrutiny through the Handbook's lens. Despite its transformative vision, neuropsychological assessment remains vulnerable to a constellation of risks—clinical, ethical, and systemic—that threaten its integrity and equity. These vulnerabilities are not merely technical but deeply embedded in power structures, resource disparities, and evolving technological landscapes.

One critical risk lies in overreliance on biological markers, particularly neuroimaging and biomarkers, without sufficient contextual integration. While PET scans and CSF analyses offer unprecedented insights into neurodegeneration and injury, they risk pathologizing normal variation when divorced from psychological and social context. For example, subtle amyloid-beta deposition detected in aging populations is often interpreted as early Alzheimer's, yet in many cases it reflects aging-related change rather than disease. The Handbook

warns against “biological determinism,” urging clinicians to interpret such findings alongside cognitive performance, psychological history, and environmental stressors. Failure to do so can lead to misdiagnosis, unnecessary intervention, and patient distress.

Equally pressing is the risk of cultural insensitivity in assessment tools. Standardized batteries, even when translated, often fail to account for idioms of distress, linguistic nuance, and sociocultural norms. In Japan, for instance, somatic complaints frequently mask cognitive decline, yet many Western-developed tests prioritize verbal recall, missing critical presentations.
