Instead, he sought to construct a *jahiliyya*-resistant political philosophy grounded in the Qur'anic notion of *khilafah*—stewardship and accountability before God. For Maududi, the caliphate was not a historical relic but a functional ideal: a system in which political authority derived from divine law (*sharia*), exercised through a morally disciplined, globally conscious community (*ummah*) with a sovereign religious framework. This redefinition was revolutionary in its coherence. Unlike earlier revivalist movements that focused narrowly on ritual or personal piety, Maududi's caliphate was a comprehensive state structure—one that integrated law, economics, education, and foreign policy into a single, divinely ordained order. His 1941 treatise *Al-Jihad al-Islami* and later magnum opus *Tafhim al-Quran* laid out this vision, arguing that true sovereignty (*hakimiyyah*) belonged exclusively to God, and that human political authority must be structured to reflect divine will. The caliph, therefore, was not merely a ceremonial figure but a constitutional guardian—chosen through scholarly consensus (*ijma*), accountable to law, and bound by covenant (*mahdud*) to serve the *ummah*. Evolution: From Jamaat-e-Islami to Global Movement Maududi's theoretical rigor found expression in institutional form through the founding of Jamaat-e-Islami in 1941, a political organization that evolved from a religious society into a transnational movement. The Jamaat was designed not as a party in the conventional sense but as a *tariqa*-state hybrid: a disciplined, hierarchical network of cadres propagating a specific vision of Islamic governance. Its structure mirrored the caliphate's ideal—centralized leadership, ideological orthodoxy, and a commitment to gradualist, systemic transformation rather than insurrection. The 1971 expulsion of Jamaat-e-Islami from Zia-ul-Haq's military regime in Pakistan—and its subsequent resurgence under Zia's Islamization policies—demonstrated the movement's adaptability.
