Her 1998 paper "Beyond the Scale: Reassessing Standardization in Trombone Pedagogy" sparked a heated debate, with proponents asserting that standardization enabled global mobility and ensemble coherence, while critics warned of a "one-size-fits-all" orthodoxy that eroded artistic diversity. The standard's response was not passive. In 2003, a revised edition introduced supplementary appendices on jazz articulation, extended range techniques, and non-Western tuning adaptations. This revision reflected a broader industry shift toward hybridization: as global jazz festivals, international competitions, and digital collaboration reshaped the trombone's performance context, the standard evolved to accommodate fluidity without sacrificing foundational discipline. The inclusion of "Improvisation Frameworks" in Book 2 (2010) signaled an institutional acknowledgment that excellence required both mastery of tradition and openness to innovation. Technological change further complicated the standard's role. Yet standardization carries inherent risks. Over-reliance on a single text can ossify practice, discouraging innovation and reinforcing power structures within musical institutions. In 2015, a high-profile incident at the International Trombone Conference saw a renowned performer criticized for “abusing” standard intonation guidelines, sparking a debate on artistic autonomy versus technical discipline. While no formal sanctions followed, the episode revealed the limits of codified excellence when confronted with individual genius. Economically, the standard’s endurance reflects its embeddedness in a vast ecosystem: sheet music sales, teacher certification, instrument manufacturing, and performance contracts all depend, directly or indirectly, on its authority. A 2021 report by the International Music Education Consortium estimated that 68% of professional trombonists cited Book 1 as a foundational text in their training, linking its use to career trajectories and institutional credibility.
