Though enforcement remained inconsistent, this event catalyzed the first codified urban fire safety policies and laid the groundwork for institutionalized fire control. Across the Atlantic, colonial America developed fire services under a pragmatic, decentralized

model. Boston's first formal fire company, formed in 1678, operated on a volunteer basis, funded by member dues and empowered by municipal ordinances. These early units were deeply embedded in civic life—members were often tradesmen, merchants, and community leaders who saw fire protection as both a professional and moral obligation.
