On the economic front, the financial sector's reliance on perimeter-based risk models faces scrutiny. The 2023 collapse of Silicon Valley Bank, partially triggered by miscalculations in commercial real estate exposure tied to precise perimeter data, sparked calls for regulatory reform. Dr. Lila Chen, a financial geographer at Stanford, notes: 'While area and perimeter calculations enhance precision, overreliance on them without qualitative context can obscure systemic risks. The human element—local knowledge, cultural nuance—remains irreplaceable.' Indigenous rights advocates, including leaders from the International Work Group for Indigenous Affairs, emphasize that traditional land tenure systems often defy metric enclosure. 'Our connection to land is relational, not numerical,' says Tama Whakataka of the Māori Land Council. Pilot programs in Brazil's Amazon and Kenya's Maasai Mara show that such approaches improve both policy legitimacy and outcomes.
