France, bound by its alliance with Russia and its own military planning, began its own mobilization on August 1, unaware that Germany had already declared war. Britain, bound by treaty to defend Belgian neutrality, entered the war on August 4 after Germany's invasion of neutral Belgium—revealing how international law, though nominally respected, was secondary to alliance obligations and strategic imperatives.
