In 2021, the African Pathology Consortium (APC) launched the Pan-African Diagnostic Competency Framework, a regionally validated alternative emphasizing tropical pathology, resource-constrained diagnostics, and community-based care. Such initiatives challenge the hegemony of Western standards, advocating for pluralistic, context-sensitive assessment models. Yet global harmonization remains a policy goal. The International Coalition of Diagnostic Societies (ICDS) promotes cross-border recognition through mutual credentialing agreements, but progress is slow. Political tensions, varying regulatory standards, and disparities in infrastructure hinder unified frameworks. The path forward requires inclusive governance—centering voices from LMICs in global standard-setting bodies.
